No Further Action for the Voluntary Cleanup at Kent Station Property including Subject: former Borden Chemical Facility, Brutsche, Reiman, Silvestri and Kent-Metro RTA Garage, bounded by James Street to the north, First Avenue North to the east, Smith Street to the south, and Fourth Avenue North to the west, Kent, Washington and Voluntary Cleanup Program #NW 1279

Dear Mr. Dennis Rattie:

Thank you for submitting the results of your voluntary cleanup actions for review by the State of Washington Department of Ecology (Ecology). Ecology appreciates your initiative in pursuing this administrative option under the Model Toxics Control Act (MTCA) to voluntarily cleanup this property.

This letter addresses the voluntary cleanup actions at the Kent Station Property including the former Borden Packaging and Industrial Products, Borden Chemical Facility, Brutsche, Reiman, Silvestri properties and Kent-Metro RTA Garage located in the central area of the City of Kent and bounded by James Street to the north, First Avenue North to the east, Smith Street to the south, and Fourth Avenue North to the west, in Kent, King County, Washington. The Kent Station Property was entered into the Voluntary Cleanup Program in June 2004 and the site number is #NW 1279.

Ecology appreciates your initiative in pursuing a voluntary cleanup under the Model Toxics Control Act. As part of the Voluntary Cleanup Program, I have reviewed the following reports and site information for the Kent Station site:

Based upon the above information Ecology has determined that, at this time, there is no known threat to the soil and groundwater that may pose a threat to human health and/or the environment.

Therefore, Ecology is issuing this determination of no further remedial action is necessary at this site under MTCA, chapter 70.105D RCW at this time. However, please note that because your actions were not conducted under a consent decree with Ecology, this letter is written pursuant to RCW 70.105D.030(1)(i) and does not constitute a settlement by the state under RCW 70.105D.040(4) and is not binding on Ecology.

Earlier this year Ecology issued a letter requesting additional soil and groundwater monitoring at the Kent Station property (Ecology letter, March 24, 2005). This recommendation was based on site information without the two most recent reports – Hart Crowser (2005) and Hart Crowser (2004A) listed above. These two reports provide sufficient site information to determine no further remedial action is necessary at this time.

Ecology's no further action determination is made only with respect to the release(s) identified in the voluntary cleanup action reports listed above. This no further action determination applies only to the area of the property affected by the release(s) identified in the reports. It does not apply to any other release or potential release at the property, and any other areas on the property.

Ecology will update its database to reflect this "No Further Action" determination.

The state, Ecology, and its officers and employees are immune from all liability and no cause of action of any nature that may arise from any act or omission in providing this determination.
