Public comment invited

Ecology invites you to comment on a proposed legal agreement called an Agreed Order (AO) between Ecology and the potentially liable persons (PLPs) Seattle Iron & Metals Corporation and 730 Myrtle LLC. The proposed AO requires the PLPs to investigate contamination, evaluate cleanup options, and develop a cleanup action plan for the site located at 730 South Myrtle Street in Seattle.

What happens next?

The proposed AO contains plans for the Remedial Investigation, Feasibility Study, Interim Action (or partial cleanups), and draft Cleanup Action Plan. The information in these reports will provide sufficient data, analysis, and evaluations so Ecology can select a cleanup alternative for the final Cleanup Action Plan. Ecology will consider all public comments, make any necessary changes, and sign the AO. Ecology will oversee implementation of the AO.

Under a water quality permit, Seattle Iron and Metals is required to install a stormwater treatment system to improve the water quality leaving the property. Before that system can be installed, Ecology is requiring them to conduct an Interim Action to cleanup potentially contaminated soil and/or groundwater at this location.

Why this cleanup matters

This site is a near the Lower Duwamish Waterway Superfund site (LDW). Contaminants in the soil and groundwater pose a risk to human health and the environment and could potentially find their way into the Lower Duwamish Waterway. Ecology, the U.S. Environmental Protection Agency, and the PLPs for the LDW are working to clean up contaminated sediments and control sources of pollution in the LDW.

Site background

The Whitehead Tyee Site at Seattle Iron & Metals Truck Parking property is currently owned by 730 Mrytle LLC. Past owners include Tyee Lumber, Whitehead Company, and Reliable Transfer and Storage Co. The property is approximately 3.22 acres and 625 feet east of the Lower Duwamish Waterway.

The site was used for commercial and industrial activities such as wood treating and milling, and repairing equipment and vehicles. Hazardous substances were released during these activities, posing a direct health exposure risk and potentially moving into the LDW.

Chemicals of concern are in site soil and groundwater. They include:


- Total Petroleum Hydrocarbons (TPH)
- Pentachlorophenol (PCP)

The following chemicals are still being investigated:

- Solvents (Tetrachoroethylene or PCE)
- Polychlorinated biphenyls (PCBs)
- Polyaromatic hydrocarbons (PAHs)
- Metals (copper, lead, and mercury)

The Cleanup Process


The Whitehead Tyee property cleanup must follow the Washington State Model Toxics Control Act (MTCA) cleanup regulations, which consists of a standard process. **Currently, Ecology is negotiating the Agreed Order.**

El Departamento de Ecología (Ecología) está invitando al público hacer comentarios sobre una propuesta Orden Acordada (Acuerdo Legal) entre Ecología, las Entidades Posiblemente Responsables (PLPs), por sus siglas en inglés), y las corporaciones Seattle Iron & Metals y 730 Myrtle LLC. Bajo la Orden Acordada, los PLPs investigarán la contaminación encontrada en el sitio, evaluarán las opciones de limpieza y desarrollarán un plan de acción de limpieza.
