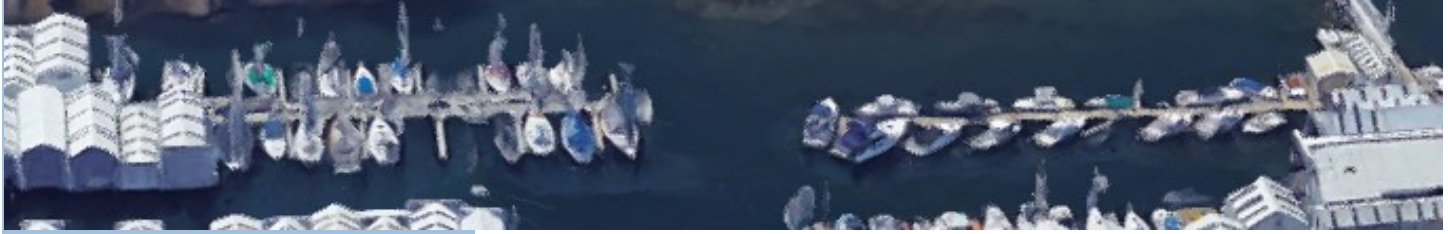

Cleanup is Complete!

Cleanup is complete at the Breakwater Marina cleanup site. The site is currently a marina, at 5603 N Waterfront Drive in Tacoma. Now, the Department of Ecology proposes removing the site from the state's Hazardous Sites List.

You are invited to submit comments on the proposed delisting from November 28 to December 28, 2016. The box on the left shows where you can find a No Further Action letter that describes how we cleaned up the site and why we believe it is complete.

Why this Cleanup Matters

For several decades, a fuel dock operated on this property. During that time, gasoline leaked into soil and groundwater from the underground storage tanks. This fuel and its breakdown products, such as benzene and lead, can be carcinogenic and harm human health and the environment.

Cleanup Activities

The fuel tanks and contaminated soil were removed in 2013. This was conducted by the property owners, under Ecology's Voluntary Cleanup Program. To clean up the site, we:

- Studied the site thoroughly to find all petroleum contamination.
- Ensured that people would not be exposed to contamination through groundwater or soil vapors.
- Removed petroleum-contamination: 658 tons of soil and 80,000 gallons of groundwater.
- Tested the soil and groundwater to confirm a successful cleanup.



What is the Hazardous Sites List?

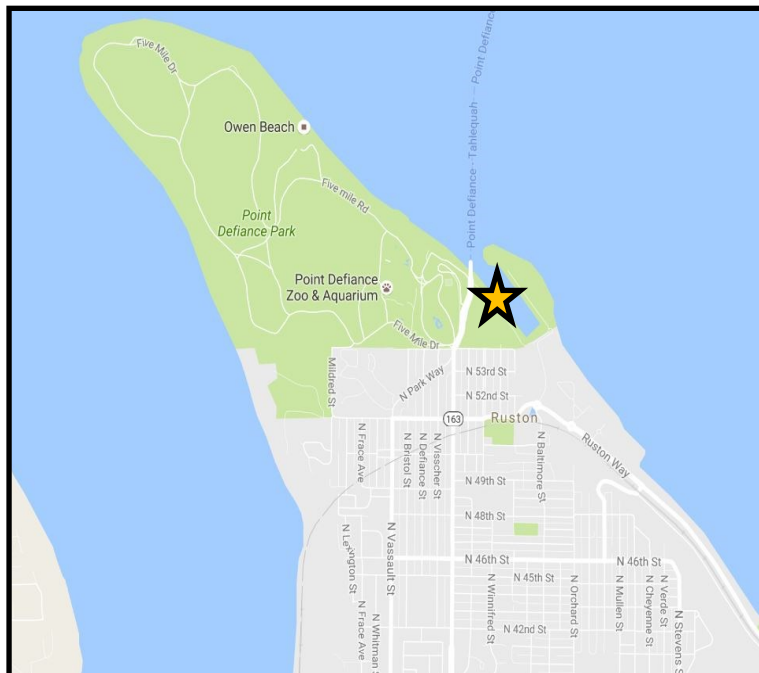
After Ecology has determined a site's potential threat to human health and the environment, it is placed on this list. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.
