Cleanup is complete!

Cleanup is complete at the Calhoun's Service Station cleanup site. The site is the current location of Sinaloa Tires, at 4540 Pacific Avenue South in Tacoma. Now, the Department of Ecology proposes removing the site from the state's Hazardous Sites List.

You are invited to submit comments on the proposed delisting from November 23 to December 23, 2016. The box on the left shows where you can find a No Further Action letter that describes how cleanup was done and why we believe it is complete.

Why this cleanup matters

For several decades, service stations have operated on this property. During that time, gasoline leaked into soil on the site. This fuel and its breakdown products, such as benzene, can be carcinogenic and harm human health and the environment.

Contaminated soil was removed in 1991, but tests in 2011 showed that some contamination was still on site, prompting the need for more work.

Cleanup activities

This cleanup was conducted by the property owners, under Ecology's Voluntary Cleanup Program. To clean up the site, we:

- Studied the site thoroughly to find all petroleum contamination.
- Ensured that people would not be exposed to contamination through groundwater or soil vapors.
- Removed 244 tons of petroleum-contaminated soil.
- Tested the soil to confirm a successful cleanup.



What is the Hazardous Sites List?

The Hazardous Sites List includes sites that Ecology has assessed for their potential threat to human health and the environment. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.
