On behalf of the Port of Seattle (Port), this Monthly Progress Report provides a summary of all activities conducted during the month of April 2017 for the Lora Lake Apartments Site (Site) in Burien, Washington. Work is being performed pursuant to the requirements of the September 9, 2015, Consent Decree No. 15-2-21413-6 (CD) between the Port and the Washington State Department of Ecology (WSDOE). This report is organized to include all requirements listed in Section XI of the CD.

- Ongoing Contractor development of pre-construction submittals for remedial construction actions at the Site.

- Partial Notice to Proceed was given to the Port's Contractor on April 28, 2017, for initiation of non-ground-disturbing site work including: mobilization, staging, setup of site security and temporary erosion controls, tree removal, and surveying.
