On October 1, 2015, the Department of Ecology (Ecology) sent Chevron Environmental Management Company (CEMC) written notice regarding your proposed status as a potentially liable person (PLP) for a release of hazardous substances at the following site:

The 30-day comment period on this preliminary notice expired on January 1, 2016.

Other than the document "*Current and Heritage Chevron LUST sites in Northwest Washington*", prepared by CEMC, dated November 9, 2009, Ecology has not received any other comments from CEMC as of November 30, 2016.

Based on the information available to date, Ecology finds that credible evidence exists which supports CEMC status as a PLP for the release at **Seattle Housing Authority Maint PKG Lot (Chevron No.: 209335)**. On the basis of this finding, Ecology has determined that you are a PLP with regard to **Seattle Housing Authority Maint PKG Lot (Chevron No.: 209335)**.

Your rights and responsibilities as a PLP are outlined in Chapter 70.105D RCW, and WAC 173-340. Ecology's site manager for the facility Dale Myers, will contact you with information about how Ecology intends to proceed with the cleanup at this site.
