
Terracon Consultants, Inc. (Terracon) is pleased to provide our response to Ecology's February 24, 2017 letter, Request for Additional Information to Provide Opinion on the Investigation under VCP for the following Contaminated Site: Site Name: Tosco Bainbridge Island Bulk Plant 1784. This letter is intended to further supplement Terracon's Site Remedial Action and Monitoring Summary Report, submitted to your attention on November 18, 2016, and the VCP Application and attached reports submitted to your attention on June 3, 2016.

Terracon has completed a Terrestrial Ecological Evaluation (TEE) for the site (attached), which determined that a simplified ecological evaluation was applicable for the site. Based on the soil impacts at the site being less than 350 square feet in area, no further ecological evaluation was necessary.

Ecology requested clarification of two other items: land use and zoning. The site is currently undeveloped. The site is located in Kitsap County, zoned as Incorporated City in the Bainbridge Eagle Harbor Waterfront neighborhood. The site is located adjacent to Waterfront Trail to the west connecting to Strawberry Park to the southwest, and adjacent to residential homes to the north, east, and southeast. The property is an approximately 60 foot by 600 foot strip of land, and based on its location, the likely future use is residential.
