WE HAVE RECEIVED YOUR WRITTEN NOTICE ACCEPTING LIABILITY FOR THE SITE. Based on the information available to date, Ecology finds that credible evidence exists which supports your status as a potentially liable person for the release at Chevron Bulk Plant USA #1328. On the basis of this finding, Ecology has determined that you are a Potentially Liable Person (PLP) with regard to Chevron Bulk Plant USA #1328.

Your rights and responsibilities as a PLP are outlined in Chapter 70.105D RCW, and WAC 173-340. Ecology's site manager for the facility Guy Barrett, will contact you with information about how Ecology intends to proceed with the cleanup at this site.
