# Interim Action Work expected to begin August 2017

Construction work for environmental cleanup at the former Unocal Edmonds Bulk Fuel Terminal 0178 site is expected to begin in August 2017. The site is located at 11720 Unoco Road, Edmonds, WA 98020. Unocal is a subsidiary of Chevron Corporation, and Chevron Environmental Management Company will conduct the cleanup under Ecology's oversight.

### What Interim Action Work will be done this summer?

### **Detention Basin Area cleanup work**

Cleanup of the Detention Basin No. 2 Area (*see map, page 2*) will begin first, with expected completion in 1 to 2 months.

- Heavy equipment will excavate and load soil onto trucks for transport to a permitted disposal facility. Trucks will enter and exit the site via State Route 104 and will not drive through downtown. There will be flaggers at the truck entrance to the site.
- Air monitoring and dust control will be performed.
- Noise will be generated by construction equipment and vehicle backup horns (required for safety).

### **WSDOT Storm Drain Vicinity cleanup work**

Chevron will install a system to extract and treat contaminated groundwater and soil vapor so that they may be discharged safely to Willow Creek and to the atmosphere, respectively, under appropriate permits. Cleanup is expected to take about 6 years.

Work to install this system is expected to begin in October 2017, with completion expected in 1 to 2 months. Contractors will use drill rigs to install extraction and monitoring wells, followed by installation of aboveground piping and treatment system equipment.

#### **Construction Hours**
