We are in receipt of the Remedial Investigation and Feasibility Study (RI/FS) Report by AEG for the above named site that showed the presence of hazardous substances above the model toxics control act (MTCA) that required cleanup. As a result, we are rescinding the April 26, 2012 no further action (NFA) determination letter issued by Ecology, you may re-apply for the NFA once you have completed the cleanup as required under the MTCA.




Fig. 3: TPH Soil Plume Map




Fig. 4: TPH Groundwater Plume Map
