

## Bothell Riverside Environmental Documents Available for comment

In 2009, the Washington State Department of Ecology (Ecology) and the City of Bothell entered into an Agreed Order to conduct a remedial investigation and feasibility study at the Riverside site shown as the triangle area in the adjacent figure.

The Riverside site is generally located at NE 180<sup>th</sup> Street & Woodinville Drive (SR 522) in Bothell. The site is separated into two cleanup areas referred to as **Riverside TPH area** (for a total petroleum hydrocarbons release) and **Riverside HVOC area** (for a halogenated volatile organic compounds release). Both areas are addressed in the site-wide draft Remedial Investigation Report described below.



Several interim cleanup actions have occurred throughout the Bothell Riverside Site. In 2010 and 2017, two separate soil excavation and removal actions were conducted to address the petroleum impacts at the Riverside TPH area.

In 2014, a ground-water pump and treat system was installed at the Riverside HVOC area. The treatment system was designed to reduce halogenated volatile organics (HVOC) impacts to the ground water and surface water. Ecology continues to work with the City of Bothell on cleanup of the HVOC plume.

## **Public Comment Invited**

Ecology invites you to review and comment on the following documents:

### **Draft Remedial Investigation (RI) Report**

The RI investigates the extent of soil and ground-water impacts to the entire Bothell Riverside site. RI activities were performed between 2009 and 2017. The contaminants of concern were TPH (lube-oil-range petroleum hydrocarbon from a former underground storage tank) that impacted the soil at the Riverside TPH area and HVOC that impacted the ground water and surface water at the Riverside HVOC area.

### **Draft Feasibility Study Report (FS) for TPH**

The FS identifies the releases, transport mechanisms, potential pathways, and exposure routes of the contaminants of concern. The FS also provides cleanup alternatives. The preferred cleanup alternative at the Riverside TPH area is excavation and off-site disposal for petroleum contaminated soil to a permitted waste disposal facility. The FS for the HVOC area will be presented at a later date.

### **Draft Cleanup Action Plan (DCAP) for TPH**

The DCAP presents the preferred remedial action at the Riverside TPH area. The preferred cleanup alternative was excavation and off-site disposal of the TPH contaminated soil. This cleanup was already completed as interim actions in 2010 and 2017. No further cleanup actions are needed for this area.

### **Updated Public Participation Plan**

Ecology also developed a site specific Public Participation Plan. The plan outlines and describes the tools and approaches that Ecology will use to inform the public about site activities, and it identifies opportunities for the community to become involved in this process.

## Documentos Ambientales de Bothell Riverside Disponibles para comentarios

Por lo general, el sitio de Bothell Riverside está ubicado entre NE 180th Street y Woodinville Drive (SR 522) en Bothell. El sitio se separa en dos zonas de limpieza denominadas **Zona de TPH de Riverside** (Hidrocarburos Totales de Petróleo) y **Zona de HVOC de Riverside** (Compuestos Orgánicos Volátiles Halogenados).

En 2010 y 2017, se llevaron a cabo dos acciones separadas de excavación del suelo y remoción para abordar los impactos del petróleo en la Zona de TPH de Riverside. No es necesario adoptar otras medidas para esta zona de TPH.


## ¿Qué sucederá a continuación?
