(Farallon) has prepared this letter on behalf of Woodworth Capital, Inc. to revise the scope of work presented in the letter regarding Addendum to Sampling and Analysis Work Plan, Woodworth Lakeview Facility Remediation, 2800 104<sup>th</sup> Street Court South, Lakewood, Washington dated October 30, 2017, from Messrs. Brani Jurista and Peter Jewett of Farallon to Mr. Jeremy Hughes of the Washington State Department of Ecology (Ecology), prepared for the property at 2800 104<sup>th</sup> Street Court South in Lakewood, Washington (herein referred to as the Lakeview Facility). This letter has been prepared in response to the email request regarding Addendum to Sampling and Analysis Work Plan – Woodworth Lakeview Facility (VCP ID No. SW1012) dated November 2, 2017 from Mr. Hughes to Mr. Jurista.

**REVISED FIELD PROGRAM SCOPE OF WORK**

The scope of work will be modified to include collecting a soil sample from 9 feet below ground surface rather than from 7 to 9 feet below ground surface from a location as close as practicable to prior soil sample A1-7040710-6 in Area of Concern 1 for analysis for total petroleum hydrocarbons as diesel-range organics and as oil-range organics, polychlorinated biphenyls, and polycyclic aromatic hydrocarbons. The scope of work for the other work elements presented in the Addendum to Sampling and Analysis Work Plan letter remains unchanged.
