Cleanup is Complete!

Environmental cleanup is complete at the MJMG Group site. The site is located at the intersection of Union Avenue and Plum Street in Olympia. It is currently a gas station, convenience store, automobile service building, and espresso stand. Ecology proposes removing the site from the state's Hazardous Sites List.

We invite your comments on the proposed delisting from December 21 to January 22, 2017. The box on the left shows where you can find a No Further Action letter that describes why we believe no additional environmental cleanup work is necessary.

Why this Cleanup Matters

Leaking underground tanks that stored gasoline led to soil and groundwater contamination with petroleum-related compounds. Soil and groundwater were both contaminated with gasoline range total petroleum hydrocarbons (TPH-G), benzene, and total xylenes, which can be harmful to human and ecological health. Based on this contamination, the site was included on the state Hazardous Sites List.

Cleanup Activities

To ensure safety of people and the environment, cleanup was confirmed under Ecology's Voluntary Cleanup Program. Cleanup activities included:

- Soil and groundwater were tested to establish the extent and nature of the contamination.
- Over 290,000 gallons of groundwater were removed and treated.
- Approximately 250 cubic yards of contaminated soil were excavated, stockpiled, and disposed of.
- Soil and groundwater were tested for petroleum contamination to verify the success of cleanup.



What is the Hazardous Sites List?

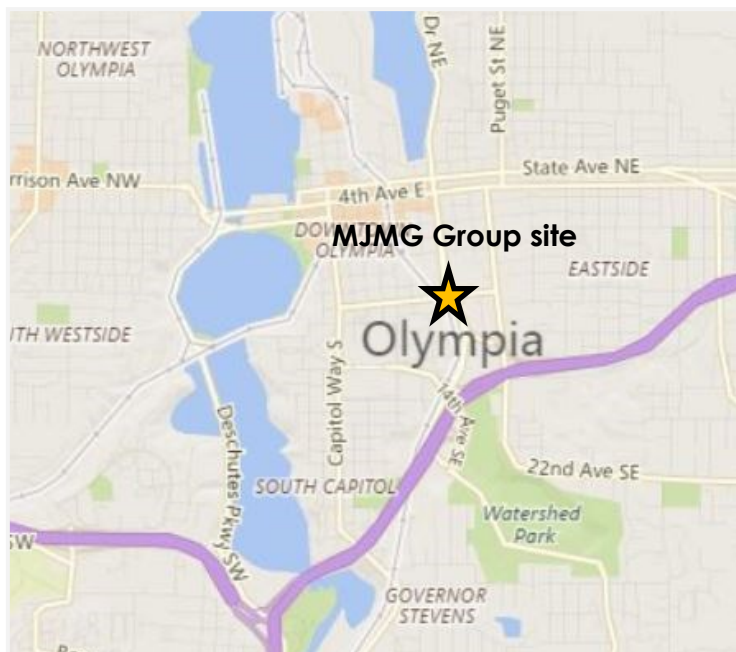
After Ecology has determined a site's potential threat to human health and the environment, it is placed on this list. Sites must go through cleanup and meet state standards before Ecology can remove them from the list.
