RE: Olympic Pipeline matters – see attached list

Dear Sir or Madam:

I am writing to advise you of a name change by Olympic Pipe Line Company. The company recently changed its name to Olympic Pipe Line Company LLC. The attached list identifies projects to which the name change applies, with the associated agency contacts for the project.

Further detail regarding the name change is as follows. Until July 31, 2017, the two shareholders of Olympic Pipe Line Company were Enbridge Holdings (Olympic) L.L.C. ("Enbridge") and Arco Midcon LLC ("ARCO"). Effective July 31, Enbridge transferred all of its stock in Olympic Pipe Line Company to ARCO, subject to the terms and conditions set forth in an agreement between Enbridge and ARCO.

Following ARCO's acquisition of all of Enbridge's stock, Olympic Pipe Line Company converted from a Delaware corporation to a Delaware limited liability company, effective August 1, 2017. The company's name was changed from "Olympic Pipe Line Company" to "Olympic Pipe Line Company LLC".

Effective September 5, 2017 ARCO sold a 30% ownership stake in Olympic Pipe Line Company LLC to SeaPort Pipeline Holdings, LLC, an ArcLight Capital Partners portfolio company.

The change in corporate name will not change the conduct of the remedial work at the projects on the attached list. BP Pipeline (North America) Inc. formerly was the operator of Olympic Pipe Line Company and remains the operator of Olympic Pipe Line Company LLC.
