In February 2016, the Low Income Housing Institute (LIHI) and the City of Olympia signed an environmental covenant (EC) as Grantors related to a Property associated with the above Site. The Washington State Department of Ecology (Ecology) signed the same EC as a Grantee. The EC was signed as part of a No Further Action determination (dated February 23, 2016) made by Ecology related to the cleanup of contamination on Thurston County tax parcel number 78503200500. This tax parcel is currently occupied by the Billy Frank Jr Place Affordable Housing Complex.

Section 2a of the EC lists requirements regarding vapor controls and reporting at the Property. Pursuant to this section, Ecology requests documentation regarding the following:

- 1) Installation of any sub-slab perforated piping.
- 2) If a passive or active vapor-mitigation system was installed, records of the required annual checks.
- 3) Installation of any sub-slab vapor barrier.
- 4) Indoor air sampling results.

Please provide the requested documentation to Ecology by May 15, 2018. Alternatively, if work is still in progress, please provide an anticipated timeline of submission of the requested information.
