On February 6, 2018, Washington State Department of Ecology (Ecology) received Rayonier Advanced Materials' (Rayonier A.M.) *Public Review Draft Remedial Investigation Report Goose Lake Site* (Landau Associates, dated January 12, 2018) by email. After review of the changes made in response to comments discussed during our calls on November 2 and 20, 2017, Ecology approves this draft and will prepare for a public comment period on it.

According to the Agreed Order, the approval of this document triggers the due date for the agency review draft feasibility study report. Originally this report was due 30 days after the approval date of the public review draft remedial investigation report. On February 1, 2018, Ecology received a request from Rayonier for an extension of the due date to March 30, 2018, since they have recently switch consultants from GeoEngineers, Inc. (GeoEngineers) to Landau Associates (Landau). Landau needed additional time to complete the feasibility study report started by GeoEngineers. Ecology approves this extension request and the agency review draft feasibility study report is now due to Ecology on March 30, 2018.
