### Re: Request for Advisory Opinion on Cleanup Action

Ballinger Village Shopping Center VCP Project No. NW1843 Aspect Project No. 150144

Dear Sonia:

We are writing to request the Washington State Department of Ecology's (Ecology's) advisory opinion on the status of the ongoing cleanup action for the Ballinger Village Shopping Center in Shoreline, Washington (the Site). Since implementing the cleanup action in 2012, the air sparging and soil vapor extraction (AS/SVE) system has significantly reduced concentrations of perchloroethene (PCE) in groundwater. As of September 2017, concentrations of PCE in groundwater are at or below the remediation levels established in the Feasibility Study and Cleanup Action Plan (FS/CAP) for active treatment. We have shut down the system and are conducting confirmation monitoring to support a No Further Action (NFA) determination from Ecology.

For reference, we have provided the 2017 Annual Progress Report for the cleanup action under separate cover for your review. Previous reports, including the Remedial Investigation (RI) Report, FS/CAP, Engineering Design Report, Construction and Startup Report, and annual progress reports for 2012, 2013, and 2014 are already on file with Ecology. Ecology issued an opinion on the RI Report and the FS/CAP in 2011 approving the site characterization and cleanup action.

As of the end of 2017, the AS/SVE system has removed a total of 671 pounds of chlorinated solvents from soil and groundwater at the Site, and reduced concentrations of PCE in groundwater by 86 percent. A detailed discussion and evaluation of performance monitoring activities performed in 2017 are provided in the attached progress report. After nearly 5 years of active remediation, the remediation system has reached a point of diminishing returns in terms of groundwater treatment and mass removal. The average reduction in PCE concentrations across the Site since startup have remained relatively unchanged from September 2016 to September 2017 (86 percent) and contaminant mass removal has tapered off.

In accordance with our conclusions and recommendations in the attached progress report, the remediation system was shut down in January to begin initial confirmation vapor and groundwater monitoring activities. The results of confirmation monitoring will be used to confirm the

effectiveness of the cleanup action in support of an NFA, and support the transition to monitored natural attenuation as outlined in the preferred remedy in the CAP.

In closing, we believe that this Site is on track for closure and are requesting Ecology's opinion on the sufficiency of the cleanup and an NFA-likely determination for the proposed approach outlined above. It is our goal to work collaboratively with you to define the final steps for closure and ensure protection of human health and the environment. We have attached a completed Request for Opinion Form, as well as updated Change of Contact Forms, so that you may begin reviewing the documentation and update your points of contact for this project. If possible, we would like to meet with you to discuss the Site prior to your detailed review and opinion.

Please let us know your anticipated timeline for a review and opinion, as well as an estimate of those costs, so we may plan accordingly. When the time comes, we look forward to meeting with you to discuss the closure of this Site. In the meantime, should you have any questions during your review, please do not hesitate to contact us.




