Dear Ms. Gray:

Thank you for your letter dated March 5, 2018, with your proposed schedule for responding to The Department of Ecology's (Ecology) comment letter on the draft Data Gaps Work Plan for the Site. We have reviewed your proposed schedule and agree with it, with the following conditions:

- Ecology does not accept the footnote stating that the schedule is "contingent on authorization of the work by the Port of Tacoma." Liability under the Model Toxics Control Act (MTCA) is not only strict but also joint and several. Ecology expects the Data Gaps Work Plan to be revised and finalized as set forth in the proposed schedule regardless, and will not approve any additional extension requests absent a showing of good cause within the meaning of Section VIII.I.2 of draft Agreed Order No. DE 14260.
- By email dated December 27, 2017, the PLP Group committed to responding "to both Ecology's [Agreed Order] text and draft work plan comments within 45 days of receipt of Ecology's draft work plan comments." To date, Ecology has not received the PLP Group's response to Ecology's most recent draft of the Agreed Order, transmitted by email on July 27, 2017. As previously explained by Assistant Attorney General Caroline Cress in emails dated November 27, 2017, and January 2, 2018, it is Ecology's understanding and expectation that Agreed Order negotiations proceed in parallel with preparation of the Data Gaps Work Plan. Accordingly, given the extended schedule for finalization of the Work Plan, Ecology expects to receive the PLP Group's response to

the draft Agreed Order no later than April 25, 2018. Pursuant to Washington Administrative Code (WAC)173-340-530(5), Ecology expects to conclude Agreed Order negotiations within sixty (60) days of receiving that response.
