The Washington State Department of Ecology (Ecology) is providing written notice of a minor modification to Agreed Order No. 8979 (Order) for the Weyerhaeuser Mill A Former Site (Site). Ecology is providing this notice in accordance with subsection L. of section VIII of the Order.

The minor modification is the change of the Project Coordinator for the Weyerhaeuser NR Company.
