We invite your comments!

Cleanup is complete at the Stutz Oil site located at 3003 Harborview Drive in Gig Harbor. The Washington Department of Ecology (Ecology) invites your comments on the proposed removal of the site from the State's Hazardous Sites List and removal of an environmental covenant (EC) which restricts development activities.

Please submit comments on this decision from April 16 to May 16, 2018. The box on the left shows how to submit comments and where to find related documents.

Site background

The site formerly contained a bulk storage facility with a warehouse, office, and five above-ground fuel storage tanks (ASTs) with associated piping. Gasoline and diesel from the ASTs leaked into soil and groundwater. Contaminants of concern included total petroleum hydrocarbons (TPH's) which can be carcinogenic and harm human health and the environment.

Cleanup activities completed

The cleanup was conducted by the property owners under Ecology's Voluntary Cleanup Program. In 2004, all structures including the ASTs and associated pipes were removed. In 2005, the majority of contaminated soil was cleaned up, and the site was graded and developed as a public car parking area with an asphalt pavement. As a result of the residual contaminated soil left in place, an EC was issued in 2009, restricting groundwater use and other intrusive activities.

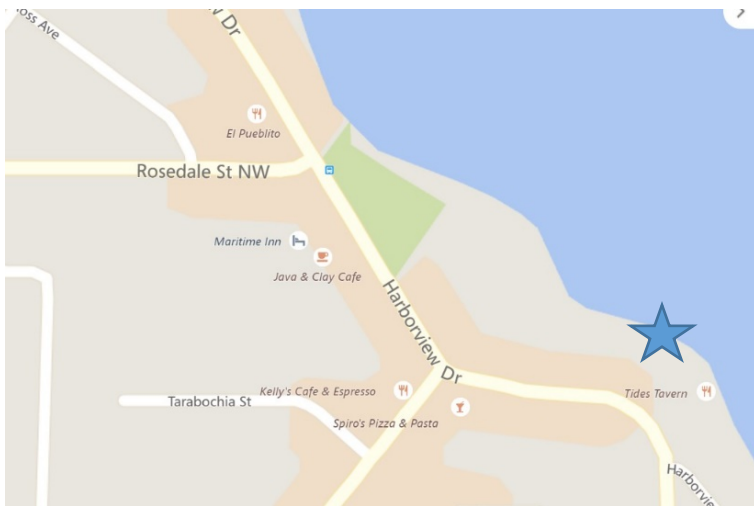
Additional soil cleanup was conducted in March 2017. Soil samples taken indicate that site soils meet the State cleanup levels and no additional cleanup is required. In addition, all groundwater samples analyzed for TPHs were below the laboratory detection limits.
