The Department of Ecology (Ecology) appreciates your decision to independently clean up the Gordon Trucking Pacific Terminal facility (Site). On April 25, 2018, Ecology received your response to our February 26, 2018, request for information. This information is needed to make a decision regarding continuance of the project in the Voluntary Cleanup Program (VCP).

Please provide the following previously requested information to Ecology by November 15, 2018:


1. **Plan and schedule for completing the cleanup.** Please provide a cleanup action plan providing sufficient information for Ecology to determine that it is likely that the Site will be cleaned up in a reasonable timeframe.
2. **Required electronic data.** Please ensure that all environmental Site data collected since August 1, 2005, are accepted into Ecology's Environmental Information Management (EIM) system database. Ecology's current data submittal requirements are provided in Toxic Cleanup Program Policy 840, available at the following location:

- 3. Next Steps.** Based on your response, Ecology will decide whether to continue providing you services under the VCP. We will notify you of our decision in writing. Please note that we will terminate the Agreement governing this Project if you do not respond to this request.
