Notice is hereby given that on June 30, 1987 the State of Washington, Department of Ecology, Claimant, first incurred costs with respect to remedial action taken under ch. 2, Laws of 1987, 3d ex. sess., codified as ch. 70.105B RCW, when the Claimant installed control measures to prevent surface water pollution from abandoned dangerous waste piles to protect human health and the environment regarding real property owned or reputedly owned, by Materials Reclamation Company, Inc.

(MARALCO) and located at 7730 South 202nd Street, Kent, King County, Washington, NE 1/4 of the SE 1/4 of Section 1, Township 22 North, Range 4 East. 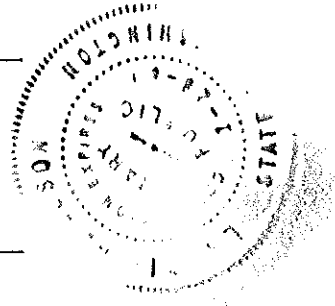
