### Cleanup process beginning for Chevron 90619 Site

The Washington Department of Ecology is working with current and historical site operators (operators) to clean up contamination at this site, located at 1205 Washington Street in Bellingham. Ecology and the operators are entering into a formal legal agreement called an agreed order to study the extent of contamination and develop a plan to clean it up.

# Ecology wants to hear from you!

We invite you to comment on the draft agreed order from **May 29-June 27, 2018.** The new agreed order requires the operators to:

- Describe the types and extent of contamination, and weigh cleanup options through an environmental report for the property;
- Choose cleanup methods through a draft cleanup action plan;
- Conduct a partial cleanup before the final cleanup plan is complete, if needed. This is called an interim action, and can occur throughout the cleanup process. If an interim action is done, we will require a separate comment period.

A draft public participation plan is also available for review. The plan describes the tools Ecology will use to inform the public and gather feedback. The blue box on the left shows where to submit comments and where you can review documents.

# Site background

The Chevron 90619 Site is located within the City of Bellingham, Whatcom County at the intersection of Elm, Washington and Broadway. The 0.61acre site is located approximately 0.4 miles northeast of Bellingham Bay (Squalicum Harbor). Gas and service stations operated at the site from about 1930 until the late 1980's. The tanks, infrastructure and building were removed in 1991. A series of coffee shops/restaurants operated at the location until 2015. A new tenant opened a butcher shop at the site in August 2017.





#### Contamination

1991 investigations showed petroleum in soil and groundwater that exceeded cleanup levels allowed under the Model Toxics Control Act (MTCA). Diesel and gasoline-range hydrocarbons, benzene, toluene, ethylbenzene, and xylenes were detected in soil and groundwater samples. The most current ground water monitoring report for the entire site was submitted in 1995. It detailed sampling results for four out of eleven wells. One well had benzene above cleanup levels. A later report looked at a portion of the Site and showed gasoline in soil above cleanup levels. These are hazardous substances under WAC 173-340-200 and may pose a threat to human health and the environment.

# What happens next?

The diagram below shows our process for cleanup and public comment opportunities. After this comment period ends we will reply to any comments received. We will then finalize the agreed order. Next, the property owners will study exactly what types and how much contamination are on site. Then they will define and evaluate cleanup options and make a cleanup action plan. Once the documents required by the agreed order are finished and reviewed by Ecology, we will make them available for public comment. A second agreed order will be required before implementing the cleanup action plan.


