

Dear Mr. Guenther:

Following our August 13, 2018 conference call with you and Sonia Fernandez, CDM Smith Inc. is transmitting documents prepared in connection with ongoing remedial actions being conducted at the above referenced site on behalf of Snohomish County (the County). Environmental Partners Inc. (EPI), on behalf of Skotdal Enterprises, is conducting ongoing remedial actions to clean up chlorinated volatile organic compounds (cVOCs) associated with releases from historical drycleaning operations conducted at the former Snohomish Square Cleaners. cVOCs have migrated in groundwater across Avenue D and impacted Snohomish County-owned property, thereby making a portion of their property part of the "site." The County has enrolled the site into the Department of Ecology's (Ecology) Voluntary Cleanup Program (VCP) with the ultimate goal of attaining a letter of No Further Action from Ecology.

EPI previously submitted a remedial investigation (RI)/Focused Feasibility Study (FFS) and Cleanup Action Plan (CAP) for the site to Ecology. Since then, the following documents have been prepared:
