Notwithstanding some minor comments presented below, Ecology hereby considers this document to be complete, pending public review and comment. Please note that the SRI Report will not be considered "Final" until the following actions have occurred:

- Ecology has approved an SRI Report Addendum presenting results of sediment sampling and the proposed MW-13 investigation. A work plan has been submitted to Ecology for review, and Ecology has provided preliminary comments on the MW-13 investigation via email.
- The SRI Report and SRI Report Addendum have completed public review. Ecology will submit both documents for public review once the Addendum has been approved by Ecology.

The following are Ecology's minor comments on the latest version of the SRI Report (received November 8, 2018):

- There are two incorrect table references on the bottom of page 48. The existing text should be changed to reference groundwater (Table 8) and sediment (Table 7). Ecology has not performed an exhaustive check of table, figure, and appendices references to see if any other references are incorrect.
- Ecology Comment on Figure 11 Cross Section B-B'. Ecology previously noted that there were two locations labeled SS04 on this cross section. The latest version of the SRI report submitted to Ecology still shows two locations labeled SS04.
- The most recent hard copy of the SRI report appendices received by Ecology (August 31, 2018) does not include Appendix N (TEE). Please mail a hard copy of the latest version of Appendix N (TEE) so we can append it for our file record.
- The electronic version of Appendices is within a compiled electronic version of the entire report dated October 1, 2018. Ecology will need an updated version of the entire report (PDF version) on DVD for use for public review.
- The title of the last comment on the bottom of page 18 in the October 1, 2018 cover letter from HydroCon has a typo (not now Table 4).

Once the Addendum has been approved by Ecology, please send me both the complete SRI Report and SRI Report Addendum in PDF format on DVD for our use in public review.
