The Department of Ecology (Ecology) received your response to our request for information on the status of the cleanup of the Gordon Trucking Pacific Terminal facility (Site). Based on your response, we have agreed to continue providing you with services under the Voluntary Cleanup Program (VCP).

Ecology notes that you have not yet provided all required Electronic Information Management (EIM) data results for the Site. For example, no soil sample results for the Site have yet been provided to the EIM database.¹ The site manager assigned to your Project has updated the SW0969 Site file to include that all required EIM data will need to be accepted to the EIM database prior to Ecology beginning our next Site review for opinion. Ecology will review the completeness of the EIM data provided for the Site prior to issuing our next opinion.

As your cleanup progresses, please keep the site manager assigned to your Project informed as to the status of the cleanup and your plan for completing the cleanup.
