Dear Mr. Suss:

The Department of Ecology (Ecology) appreciates your decision to clean up the Sumner National Auto Parts facility (Site) independently. However, our records indicate that you have not conducted any remedial actions for some time. This letter requests information on the status of your cleanup and your continued interest in the Voluntary Cleanup Program (VCP).

Request for Information

- 1. Within 30 days of the date of this letter, notify Ecology if you plan on staying in VCP or if you plan to terminate the VCP Agreement. If you plan on terminating, the VCP Site Manager can provide you with a letter template to finalize your termination.
- 2. If you plan on continuing in VCP, provide a plan for completing the cleanup within 180 days of the date of this letter. In a letter dated July 12, 2017, Ecology provided comments on your work plan to conduct excavation of contaminated Site soils and install monitoring wells. Ecology's records indicate you last discussed the SW1547 cleanup with Ecology by phone on July 24, 2017, and August 3, 2017. Please provide a report describing any cleanup actions taken, and to detail how the Site will be cleaned up in a reasonable timeframe.

3. Required electronic data. Please ensure that all environmental Site data collected since August 1, 2005, are uploaded into Ecology's Environmental Information Management (EIM) system database, as required by WAC 173-340-840(5) and Ecology Policy 840. Ecology's current data submittal requirements are provided in Toxic Cleanup Program Policy 840, available at the following location:

4. Next Steps. Based on your response, Ecology will decide whether to continue providing you services under the VCP. We will notify you of our decision in writing. Please note that we will terminate the VCP Agreement governing the SW1547 project if you do not respond to this request within 30 days of the date of this letter.
