Why you received this information

The J H Kelly Inc. cleanup site (site) is located at 821 3rd Ave in Longview. You may live or own property near the site, which is the reason you received this information in the mail.

Public comment invited

The Department of Ecology (Ecology) ranked the site's relative risk and put it on the state's Hazardous Sites List. After cleanup, Ecology determined the site meets state cleanup levels and no further cleanup actions are needed. Once a ranked site is cleaned up, a public comment period is required before a site can be removed from the list.

Ecology invites your comments about removing the site from the list from **April 11 to May 12, 2019**.

After the comment period, we will post responses to the site webpage (see blue box on the left). Your comments are considered before the site is removed from the Hazardous Sites List.

Cleanup

In 1991 petroleum hydrocarbon contamination was found at the site when two underground storage tanks were removed. Additional soil was excavated from the area where the tanks were located and the soil and wastewater were removed from the property. Groundwater was monitored at the site off and on from 1991 to 2016.

Ecology ranked the site a 2, with 1 being the highest relative level of concern compared to other sites. After ranking the site, it was placed it on the Hazardous Sites List.

In 2016, the owner entered Ecology's Voluntary Cleanup Program to clean up the site on their own. Soil collected from where the former underground tanks were located verified that petroleum contamination of soil was below state cleanup levels.

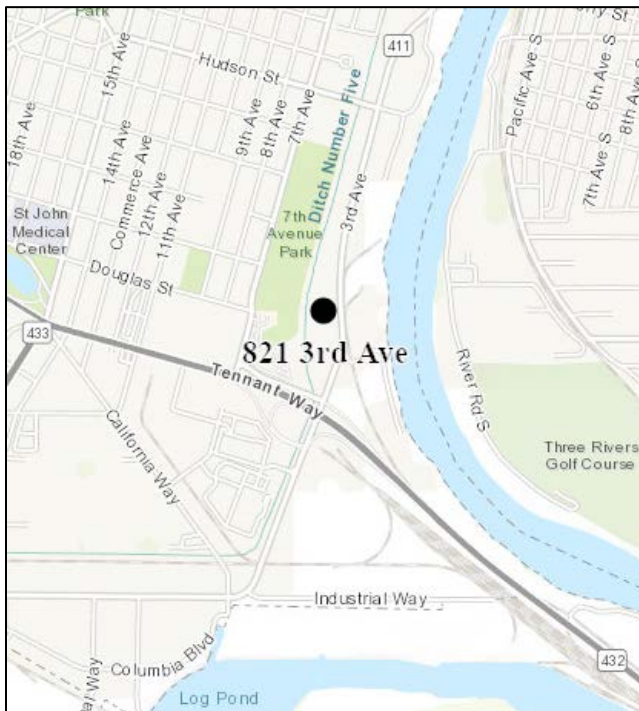
The owner installed groundwater monitoring wells near the former tank locations. Quarterly groundwater sampling conducted in 2018 confirmed that petroleum contamination of groundwater at the site was below state cleanup levels.
