Description of proposal

Under the Soil Safety Program Ecology will do the following at these locations:

- 1. American Lake Park, City of Lakewood, 9222 Veterans Dr SW Lakewood, WA 98498— Under the Soil Safety Program, Ecology will remove approximately 1,850 cu yards of contaminated soil from an area approximately 49,750 sq ft primarily consisting of existing lawn mixed with trees. In the existing lawns areas, the 12-inch deep excavation will be completed by traditional excavation and/or use of vacuum truck. Excavation will only go as deep as tree roots will allow, up to a maximum of 12 inches. Confirmation samples will be collected from the 12-to 18-inch layer to assess if additional soils should be removed. The void left from the removal, will be backfilled with clean topsoil to the same profile that existed before. The new topsoil will be hydroseeded. Landscape bark would be applied to the root flares around the trees.
- 2. Kiwanis Park, City of Lakewood, 6002 Fairlawn Dr SW Lakewood, WA. Under the Soil Safety Program, Ecology will remove approximately 290 cu yards of contaminated soil from an area approximately 7800 sq ft primarily consisting of existing lawn mixed with trees. In the existing lawns areas, the 12-inch deep excavation will be completed by traditional excavation and/or use of vacuum truck. Excavation will only go as deep as tree roots will allow, up to a maximum of 12 inches. Confirmation samples will be collected from the 12-to 18-inch layer to assess if additional soils should be removed. The void left from the removal, will be backfilled with clean topsoil to the same profile that existed before. The new topsoil will be hydrosceded. Landscape bark would be applied to the root flares around the trees.
