Dear Dan Carrier:

According to Agreed Order No. DE 7111 (Order), you are the designated project coordinator for implementation of the scope of work required at the Chevron Bulk Plant USA 1348 (formerly Bowman Oil & Propane) cleanup site on behalf of Chevron U.S.A., Inc. (Chevron). It has been brought to my attention that you are no longer Chevron's primary point of contact for this project.

The Order states you are responsible for overseeing the implementation of the work required by the Order. To the maximum extent possible communications between Ecology's project coordinator and Chevron will be directed through you. Either party may change its project coordinator with written notification to the other party prior to the change. If Chevron would like to change its designated project coordinator, you or an authorized representative of Chevron, must provide written notification to Ecology. The notice should include the contact information for the new coordinator.

In addition, Chevron is still in the process of conducting the work described in the March 20, 2018, *Remedial Investigation Work Plan Addendum* prepared by Leidos, Inc.

A November Progress Report submitted by Leidos, Inc. on December 2, 2018, indicates all of the remaining investigation locations will be completed by March 30, 2019. **If the investigation cannot be completed by this date, please submit a request for an extension of schedule in accordance with Section VIII.K of the Order.** The request must include: an updated schedule to complete the remaining scope of work required under the work plan.
