

WAC 197-11-970 Determination of nonsignificance (DNS).

DETERMINATION OF NONSIGNIFICANCE

Description of proposal

Under the Soil Safety Program Ecology will perform soil safety actions at these locations:

1. **Sunset Playfields** - Under the Soil Safety Program, Ecology will remove approximately 1775 cu yards of contaminated soil from an area approximately 1.1 acres. The area will be backfilled with clean soil and hydroseeded.
2. **McMicken Park** - Under the Soil Safety Program, Ecology will remove approximately 195 cu yards of contaminated soil from an area approximately 5250 sq ft. The area will be backfilled with clean soil and hydroseeded.
3. **Dottie Harper Park** - Under the Soil Safety Program, Ecology will remove approximately 280 cu yards of contaminated soil from an area approximately 7500 sq ft. The area will be backfilled with clean soil and hydroseeded.
4. **Cami Ditolla** - Under the Soil Safety Program, Ecology will lay geotextile fabric and cover with nine inches of play chips the play area that is approximately 2450 sq ft.
