Aspect Consulting, LLC (Aspect) is pleased to provide the eighth Progress Report on behalf of the potentially liable persons (PLPs), FH Brooklyn, LLC (FH Brooklyn) and Chevron Environmental Management Company (EMC), who are signatories to an Agreed Order (No. DE 13815, effective January 11, 2017) with the Washington State Department of Ecology (Ecology).

The Agreed Order requires that the PLPs submit quarterly progress reports (Section VII.D) to Ecology until satisfaction of the Agreed Order. The reporting period for this Progress Report No. 8 is October 1, 2018 – January 15, 2019.

# **Progress Made During the Reporting Period**

- Dewatering and permitted discharge continued after completion of the Interim Action remedial excavation and was discontinued on October 29, 2018.
- Aspect delivered the Agency Review Draft Interim Action Report to Ecology by the Agreed Order due date on December 10, 2018.
- Ecology approved the Agency Review Draft as Final. Aspect issued the Final Interim Action Report on January 4, 2019; this was the last Interim Action deliverable required by the Agreed Order.
- Leidos and Chevron EMC are continuing to work with the respective property owners to obtain signed access agreements. An access agreement between EMC and Safeway Inc. was signed on November 9, 2018. Active and ongoing discussions between UDPA and EMC on terms of the access agreement are still being negotiated. The most recent version of the access agreement between UDPA and EMC was sent to UPDA on January 16, 2019. Due to the legal nature of the emails, they are not being included as attachments.

## **Activities Planned for the next Reporting Period**

- Leidos and Chevron EMC will continue to work with UDPA 4701 LLC to obtain signed access agreements.
- Leidos and Chevron EMC will continue to work with the City of Seattle, FH Brooklyn, and Ecology to install monitoring wells MW-20 through MW-23.
- Continued RI field investigations including quarterly groundwater monitoring.

The next quarterly progress report will be submitted on or before April 15, 2019.
