This letter is in response to the April 5, 2019, letter from Cascadia Associates, LLC on behalf of NuStar Terminals Services, Inc.¹ (NuStar), requesting cessation of quarterly progress reporting required by the above referenced Agreed Order (AO). The Department of Ecology (Ecology) approves this request. No project progress reports are required starting January 1, 2019.

Ecology considers this a minor change to the AO. As required in Section VIII.L (Amendment of Order) of the AO, minor changes agreed to by the parties verbally are documented in writing by Ecology. Public notice and comment is not required for a minor amendment. With this letter, the AO is being modified to discontinue the requirement that NuStar prepare and submit quarterly progress reports as detailed in Section VII.C (Work to be Performed).
