IT IS HEREBY MUTUALLY AGREED, by and between the PORT OF ANACORTES, a Washington municipal corporation, herein referred to as "Lessor", and Frontier Industries, Inc., a Washington Corporation, hereinafter referred to as "Lessee", that this agreement amends the NON-PREFERENTIAL, REVOCABLE LEASE AGREEMENT between the parties hereto, dated April 1, 1986, and subsequently amended by FIRST AMENDMENT dated July, 16, 1986, and further amended by SECOND AMENDMENT dated September 10, 1987, (the "Lease").

WITNESSETH -

In consideration of the mutuality of benefit inherent hereto, the parties hereto do mutually agree as follows:

- 1. <u>PROPERTY DESCRIPTION:</u> The property referred to in the Lease as "the Premises" is hereby changed to the property legally described in Exhibit "A" and is depicted and highlighted in Exhibit "B", both of which are attached hereto and incorporated herein as though fully set forth here.
- 2. <u>TERM</u>: The Lease is hereby amended to provide that the term shall be on a month to month basis beginning November 1, 1995, and that the Lease may be canceled by thirty (30) days advance written notice by either party.
- 3. <u>RENT:</u> The Lease is hereby amended to provide that the Lessee shall pay to Lessor, in lawful money of the United States, without any set-off or deduction, in addition to taxes, assessments, and other charges required to be paid hereunder by Lessee, rent for the Premises of :

35,125.Square Feet @ .0033/S.F. per month = \$ 117.08

plus applicable Washington State leasehold tax. Rental payments shall commence beginning November 1, 1995. The rent for each month shall be paid to the Lessor in advance on or before the first day of each and every month, and shall be paid at such place as the Lessor may hereinafter designate.

4.. <u>ENTIRE AGREEMENT:</u> All other terms and conditions of the NON-PREFERENTIAL REVOCABLE LEASE AGREEMENT dated April 1, 1986, and subsequently amended by FIRST AMENDMENT dated July, 16, 1986, and further amended by SECOND AMENDMENT dated September 10, 1987, except as herein amended to the contrary, are confirmed, ratified and continued in all respects and are to remain in full force and effect. This agreement shall bind and inure to the benefit of the successors and assigns of the Port, and the successors and assigns of Lessee.

EXHIBIT "A"

LEGAL DESCRIPTION
