STATE ENVIRONMENTAL POLICY ACT DETERMINATION OF NONSIGNIFICANCE (DNS)

Description of proposal: Site work will include cleanup construction activities and associated monitoring conducted in accordance with an Ecology-prepared Cleanup Action Plan. Major cleanup-related actions will include excavation; drum/waste removal; off-site disposal of hazardous substances; thermal treatment of residual contamination; cover system installation/ restoration; and maintenance and monitoring of engineered cover systems previously installed as an interim action containment remedy.

Location of proposal:

The Pasco Landfill. The project area includes portions of the following sections in Township 9 North, and Range 30 East Willamette Meridian: the SE ¼ of Section 15; the SE ¼ of Section 16; the NE ¼ of Section 21; and the NW ¼ of Section 22. The landfill property includes all or portions of assessor parcel #'s 113-580-082; 113-580-091; 113-580-117; 113-580-135; 113-580-126; 113-200-072; 113-580-037; 113-510-059; 113-580-064 in Franklin County, WA.
