Ecology notes your statements concerning the "abandoned building", the current observed status of the UST's, and development of a work plan for removal of the existing underground infrastructure.

Jim, your letter states that you are arranging a meeting with Mr. Steven Spencer to begin to develop a work plan for the removal of the underground infrastructure.

You will need to coordinate this work plan with Chevron and Nordic in the development of this work plan.

Ecology will need to review the draft Work Plan and approve it.

Note: Removal of the underground infrastructure will be considered an Interim Action, which Ecology will support.

An Interim Action under the Agreed Order will require Public Comment, Ecology will need to develop the following:

- Interim Action Work Plan Fact Sheet
- Notice of Interim Action Work Plan Newspaper Display Ad
- Schedule a 30-day Public Comment Period

Again, Ecology supports an Interim Action for removal of the existing underground infrastructure.
