Aspect Consulting, LLC (Aspect) is pleased to provide Progress Report No. 5 on behalf of potentially liable persons (PLPs) Strickland Real Estate Holdings (SREH) and Chevron Environmental Management Company (CEMC), who are signatories to Washington State Department of Ecology (Ecology) Agreed Order (AO) #14315, effective September 10, 2018. The AO requires that the PLPs submit quarterly progress reports to Ecology until satisfaction of the Agreed Order.

This Progress Report No. 5 is for the fourth quarter 2019 reporting period.

Progress Made During the Reporting Period

In the fourth quarter of 2019, Aspect finished implementation of the field work outlined in the Remedial Investigation Work Plan (RIWP):

- All remaining investigation-derived waste (IDW), consisting of light non-aqueous phase liquids (LNAPL) and purged groundwater, was removed from the Site on November 26th and disposed of at a permitted facility.
- The second groundwater sampling event was conducted on November 19th and 20th, 2020. Street closure and traffic control was used on November 19th to sample MW-16 and MW-17.
- Data validation of soil, groundwater, and soil gas analytical results has been completed.
- LNAPL recovery testing was conducted during the third quarter of 2019 and began with the evacuation of LNAPL from MW-5 and MW-8 in early August 2019. LNAPL in MW-8 recovered to its equilibrium thickness, and an LNAPL recovery test was started in early September. Long-term LNAPL recovery was monitored weekly in accordance with Task 7 of the RIWP. In late September and October, rising groundwater elevations resulted in decreasing LNAPL thicknesses at all monitoring wells. Therefore, weekly LNAPL recovery gauging was suspended on October 1st, and the available data will be used to calculate transmissivities as described in the RIWP.

Sampling and/or Testing Reports Received

- Aspect collected and submitted 14 groundwater samples during the second groundwater sampling event, and those samples were analyzed for COCs in accordance with Section 6.5 and Appendix E of the RIWP. The laboratory analytical report has been received and submitted to the third-party validator.
- All validated data received to date has been submitted for upload to Ecology's Environmental Information Management database.

Summary of Deviations from the AO or Approved Work Plan

• No deviations from the AO or approved RIWP occurred during the fourth quarter of 2019.

Contacts with Other Entities or Public

• None.

Potential Problems and Suggested Solutions

• No potential problems are anticipated for first quarter 2020 activities.

Changes in Key Personnel

• No changes in key personnel occurred in the fourth quarter of 2019.

Activities Planned for the Next Reporting Period

- Receive validated results from the second round of quarterly groundwater sampling, and upload to EIM.
- Conduct a Key Project Meeting per the AO with Ecology for the Remedial Investigation Pre-Report Check-In. A data package of Draft Remedial Investigation tables and figures will be submitted to Ecology in advance of this meeting.

The next quarterly progress report will be submitted on or before April 15, 2020.

Agreed Order #14315 requires email status updates during implementation Remedial Investigation Work Plan (RIWP) activities to Ecology on the 1st of 15th of each month. The first email status update was transmitted on June 17th. The RIWP field implementation activities are complete and the only activity remaining is data validation. Therefore, this is the final email status update for RIWP implementation activities. AO progress reporting will continue quarterly with the next instance due on 1/15/20 which is anticipated to include validated analytical results from the RIWP activities.

The following is the status of each RIWP task:

- Task 1 Permitting, Access Agreements, Locating, and Health and Safety Planning Complete.
- Task 2 Geophysical Survey Complete.
- Task 3 Boring and Monitoring Well Installation The final drum of groundwater IDW generated from RI activities was removed from the property on November 26th. This task is **complete**.
- Task 4 Soil Vapor Sampling Complete.
- Task 5 Soil and Groundwater Analyses The second groundwater sampling event was conducted on November 19 and 20, 2019. This task is **complete**.
- Task 6 Data Validation All data received to date has been validated by a third party. Results from the second groundwater sampling event are expected back the week of 12/2 and will be transmitted for third party validation.
- Task 7 LNAPL Recovery Testing Complete.
