## Dear Scott Hooton:

Thank you for revising the Interim Action Report (report)<sup>1</sup> in response to our previous letter.<sup>2</sup> Ecology has no further comments on the report. Therefore, please consider the report as approved.

As stated in our previous letter, <sup>2</sup> submittal of the Interim Action Report is not the only remaining required deliverable before Agreed Order DE13921 can be considered complete. As of this date, the remaining deliverables consist of:

- 1. Finalization and Recording of the Environmental Covenant.
- 2. Submittal of electronic data to Ecology's Environmental Information Management (EIM) System database, as required by Agreed Order section VIII.E. It does not appear that data collected after December 28, 2016, have been entered into EIM.

Please also note that because the scope of this Order was limited to performing an interim action on a portion of the TWAAFA Site, satisfaction of the Order's requirements will not necessarily mean that no additional remedial action will be required for this portion of the Site. Ecology will be issuing a new Administrative Order in the near future requiring completion of a Site-wide remedial investigation/feasibility study and preparation of a preliminary draft Cleanup
