Dear Mr. Myers:

On behalf of Chevron Environmental Management Company (CEMC), Nordic Properties, Inc., and Victory Business Park, LLC (collectively, the PLPs), Leidos, Inc. (Leidos) is providing this progress report to document activities performed to satisfy the requirements of Agreed Order No. DE 14246 for the above-referenced site (the Site) located at 2021 6th Street in Bremerton, Washington. This report summarizes activities completed from June 1 through 30, 2020.

ACTIONS TAKEN TO COMPLY WITH THE AGREED ORDER

- On June 10, representatives for the PLPs met with Ecology via a web-based meeting to review the results of RI activities completed to date and discuss completion of the RI.
- On June 16, Ecology provided comments by email on items discussed during the June 10 meeting. Specifically, Ecology stated that Leidos' proposal to use sitespecific soil cleanup levels at the Site is appropriate. In addition, Ecology requested additional sampling to further assess the potential of petroleum-vapor intrusion (PVI). Ecology specified that the additional soil vapor sampling should include:
 - o Another round of sampling at locations SVP-4 and SVP-5 (resampling at the SVP-6 location was also suggested);
 - o Laboratory analysis to quantify petroleum equivalent carbon fractions, using the Massachusetts DEP APH test methods; and

- Modification of the sampling and/or laboratory analytical methods in order to provide for a lower reporting limit for quantification of naphthalene.
- Leidos evaluated alternatives for analytical laboratories and sampling methods to address Ecology's request for additional vapor intrusion assessment at the Site.

• No sampling, testing, or other data reports were received during this reporting period.

DEVIATIONS FROM THE APPROVED WORK PLAN

• None during this reporting period.

• Leidos did not engage with representatives of the local community, public interest groups, press, or federal, state, or tribal governments during this reporting period.
