Tamara Welty has completed her review, and her recommendation is to list the site on the Confirmed & Suspected Contaminated Sites (CSCS) List.

However, we may be able to reach an NFA if we had more groundwater information. If you could provide three groundwater samples down-gradient of the remediated soil we would re-evaluate. (Note that TPH-D and TPH-O results from groundwater samples must be added and compared to the Method A groundwater cleanup level of 0.5 mg/L.)

Please let me know if your client would approve this additional wok, or if you'd like me to move forward with listing the site.
