The Department of Ecology (Ecology) walii galtee Ajajni Irratti Walii galame (Agreed Order, AO) jedhamu Chevron Environmental Management Company (CEMC) fi Stone Way Apartments LLC (Stone Way) waliin Bakka Chevron 209335 qulqulleessu walii galtee raawwateera.

Agreed Order (AO)'n CEMC fi Stone Way dhaan akka bakka bu'aa fi itti gaafatamaatti moggaasudhaan akka isaan qorannoo furmaata, qorannoo bu'aa (RI/FS) gabaasa fi wixinee karoora gochaa qulqullinaa (dCAP).

Geessituu kara bitarra jiru fayyadamuun Muddee 7,2020 - Ammajjii 20,2020tti sanadii armaan gadii ilaaludhaan akka yaada irratti laattaniif isin affeerraa.

- **Agreed Order** – PLP dhaan akka haala naannoo akka qoratuuf, gabaasa RI/FS bu'aa qorannichaa kan dhi'eessu fi madaallii filannoo qulqulleessuu akka dhi'eessuuf gaafata. dCAP immoo filannoon qulqulleessuf dhi'ate sun akkamitti akka raawwatamu ibsaa.
- **Karoora hirmaannaa hawaasaa** – Akkaataa Ikoolojiin hirmaannaa haawaasni hojii fi carraa bakka qulqullinaa keessatti qabuu ibsa.

Bakkichi 1215 N 45th Street, Seattle, WA 98103 (qabeenya) argama. Qabeenyummaan isaa yeroo ammaa kan Stone Way yemmuu ta'uu gamoo tajaajila adda addaa kennuu fi gatii madaalamaa ta'ee tajaajilaa jira.

Iddoo qabeenyichaatti bakki tajaajilaa yoo xiqqaate bara 1935 kaasee hojjecha jira. Standard Oil Company (Bu'uura) (duursaa Chevron U.S.A. Inc.) 1954tti qabeenyicha bituudhaan hanga 1969 tajaajilli bakka gamoo fi gaaraajii sun kaafamuutti boba'aa dhi'essudhaan hojateera. Standard bara 1978tti dha kan Seattle Housing Authority (SHA) gurgure. Ergasii SHA immoo qabeenyicha bara 2005 Housing Resources Group (HRG)tti gurguree, innis atattamaan qabeenyummaasaa Stone Way'tti dabarsee. Ergasiis qabeenyichi gara mana keessumaa, tajaajila wal makaa, mana jireenyaa fi jala isaatti bakka konkolaataa qabutti geddameera.

Hojii qulqullessuu duraa

2005: sadarkaa jalqaba ture irraa gadi fageenya 13 hanga 18tti qabeenyichi qotamuudhaan biyyoon miidhamaan gatameera. Dabalataanis, walii galaan gara baaldii diyaameetirii 20 kan ta'u urtuudhaan iddoo dur ture irraa gara eejjannoo 42 gadi deemudhaan boba'aan kaafameera. Tilmaamaan gara biyyoo toonii 2,490 gatamuudhaan biyyoo qulqulluu ykn control-density fill (CDF) dhaan bakka buufameera. Kuufamnni lafa jalaa shan akkasuma qabeenyicha irraa fuudhamaniruu. Bakki konkolaataa itti dhaban inni jalaa North 45th Street, Stone Way North fi koriidarii tajaajilaa isa qootisa dabalataa dhorketti aanee jira. To'annoon boolla bishaani lafa jalaa dabalataas bara 2005 dhaabameera.

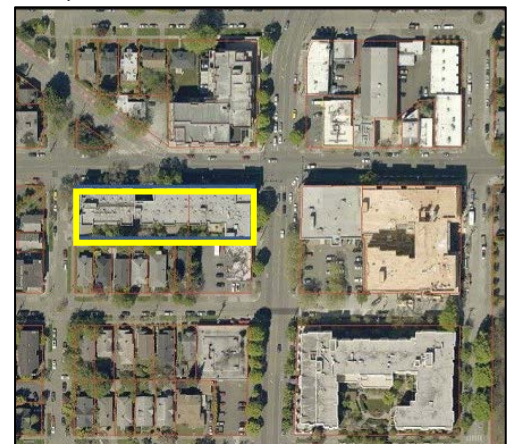
2005 – 2018: 2018 keessa fakkeenya bishaan lafa jalaa kan waggaaatu walitti qabamee. Dabalataanis, dhangala'aa kan hin taane (LNAPL ykn boba'aa bolla bishaanii gararraa kan ciisu) boolla to'annoo sanaan fuudhamera (torbeedha fi guyyaatti) Gurraandhala 2006 hanga hagayya 2006tti. Oomicha jiidha hir'isu foyya'insi LNAPL akka itti fufuuf 2013 godhameera.

2018 – Har'a: LNAPL bakkicha 2018 gutummaa keessa bolla bishaan lafa jalaa to'achuu isaa itti fufeera. tuxxuqaan boba'aa fayyaa fi daldala jiraatoota gamoochaa irratti bakka konkolaataa mana jala jiruun, gaaraajii qilleensa'a fi qillensota eegumsaa gamoo jalaa wal qabatee yaaddo tokko iyyuu hin qabu. Vapor Intrusion Assessment (VIA ykn qorannoo qilleensa gaaraajii keessaa) hubannaa kana mirkaneessuuf yeroo qorannoo furmaata ni geggeefamaa.

Yaaddoo Keemikaalaa

- Oomisha boba'aa (Gasoline, Diesel, Oil-range Total Petroleum Hydrocarbons)
- Benzene, Toluene, Ethyl-Benzene, and Xylene (BTEX)

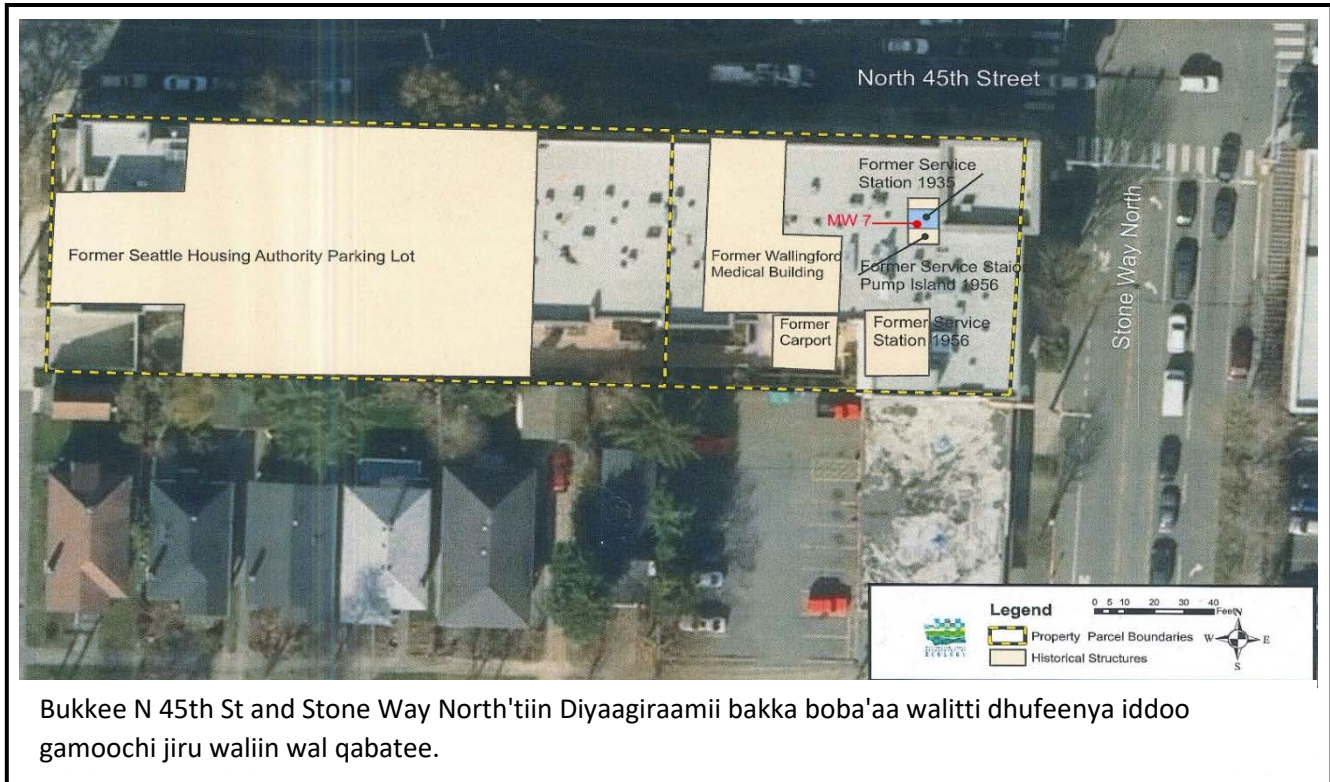

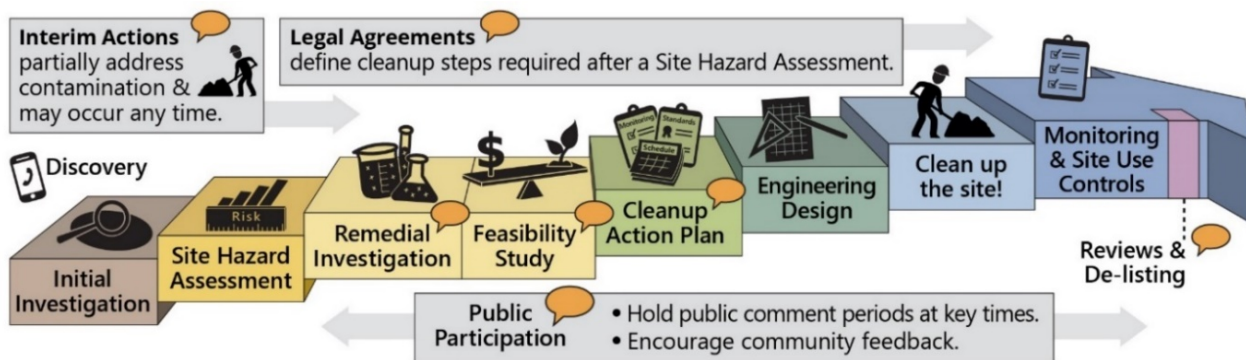
