TERMINATION & RELEASE OF RESTRICTIVE COVENANT

Grantor: State of Washington Department of Ecology

Grantee: Union Oil Company of California, a California corporation

Legal Description: Northeast quarter of the Southwest quarter of Section 24, Township 5 North Range 1 West of Willamette Meridian. Detailed Legal Description is presented below.

Original Restrictive Covenant No. 3160136 recorded in Cowlitz County on 09/23/2002 (Enclosure A).

Pursuant to the Model Toxics Control Act, Chapter 70.105D RCW (MTCA), the Uniform Environmental Covenants Act, RCW 64.70.100, and WAC 173-340-440, the State of Washington, Department of Ecology (Ecology) has determined, after public notice and comment, that the Environmental Covenant (here after "Covenant") filed of record in Cowlitz County under Auditor File Number 3160136 on September 23, 2002 between Union Oil Company of California and Ecology as Grantee or Holder of the Covenant over the property legally described as below is no longer necessary under the Model Toxics Control Act (MTCA) and its implementing regulations, Chapter 173-340 WAC in order to protect human health and the environment and the integrity of the remedial action. Ecology hereby consents to termination and release of the Covenant and relinquishes and quitclaims to David L Wells, any and all rights it may have that were created by the Covenant.

This document is not a settlement under MTCA. Ecology's signature below does not constitute a covenant not to sue or a compromise of Ecology's authority or rights other than those rights created by the Covenant itself.

The legal description of the property subject to the Covenant is as follows:

That certain real property situated in the County of Cowlitz, State of Washington, as follows:

A track of land in the Hans K. Craft Donation Land Claim and in the Northeast quarter of the Southwest quarter of Section 24, Township 5 North, Range 1 West of Willamette Meridian lying South of Goerigs Second Addition to Woodland and East of the East right of way line of the Northern Pacific Rail Road, more particularly described as follows to-wit;

BEGINNING at an iron pipe in the center of Sixth Street on the South boundary of Goerigs Second Addition to Woodland 410.0 feet South of a monument set at the intersection of the center lines of 6th Streets and Division Ave in Woodland:
thence West on the South boundary of Goerigs Second Addition 260 feet;
thence South 3° 12' East 200 feet along the East line of the Northern Pacific Rail Road right of way;
thence East 260.0 feet;
thence North 3° 12' West 200 feet to the point of beginning.

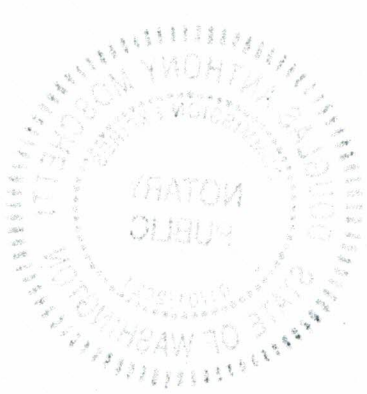

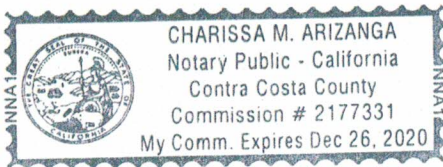


