Thank you for working with the Washington State Department of Ecology (Ecology) on the Pacific Wood Treating Site (Site). This letter provides written notification that the actions required by the De Minimis Consent Decree No. 20-2-01609-6 (De Minimis Decree) have been satisfactorily completed and that no further action by Union Pacific Railroad Company is necessary. The De Minimis Decree became effective on August 31, 2020.

Satisfaction of De Minimis Decree

The payment required by the De Minimis Decree in Section VI (Payment to Ecology) has been received and processed by Ecology into a Cleanup Settlement Account for the Site. Ecology has determined the requirements of the De Minimis Decree have been satisfied. Ecology made this determination pursuant to Section XIII (Duration of Decree).

No Further Action by Union Pacific Railway Company Determination

Ecology has determined that no further action by Union Pacific Railway Company is necessary at this Site.

Dismissal of the De Minimis Decree

Based on the above determinations, Ecology has decided to dismiss the De Minimis Decree. The Attorney General's Office will seek joint dismissal of the De Minimis Decree in Clark County Superior Court.

Upon dismissal of the De Minimis Decree, Section VIII (Retention of Records) will remain in effect for ten years from the date the De Minimis Decree is no longer in effect. Sections X (Covenant Not to Sue), Section XI (Contribution Protection), Section XII (Indemnification), and Section XIV (Claims Against the State) will remain in effect in perpetuity.
