# **Public Outreach Summary**

From December 7, 2020 to January 20, 2021, the Department of Ecology (Ecology) solicited public comments on a draft agreed order (legal agreement) and public participation plan for the Chevron 209335 site. The legal agreement between Ecology, Chevron Environmental Management Company (CEMC) and Stone Way Apartments LLC (Stone Way) will require these potentially liable persons (PLPs) to investigate the site and develop cleanup alternatives. The documents detailing their findings is called a Remedial Investigation/Feasibility Study (RI/FS) Report. The PLPs will develop a plan based on that report called a draft Cleanup Action Plan (dCAP).

Our public involvement activities related to this 45-day comment period included:

- Fact Sheet:
  - US mail distribution of a fact sheet providing information about the cleanup documents and the public comment period to approximately 5,000 households and other interested parties.
  - Hard copy distribution of all translated fact sheets were provided to Stone Way Apartments to be distributed to residents who were known to require these specific translations.
  - Digital copies of all English, Spanish, Somali, Tigrinya, Amharic, Chinese-Simplified, and Oromo fact sheets were located on the site webpage<sup>4</sup>.
- Public Meetings:
  - Two virtual public meetings held on December 15, 2020 (6:00-7:00pm) and December 17, 2020 (9:30-10:30am) using Webex. Dynamic Language provided simultaneous interpretation in Spanish, Somali, Tigrinya, Amharic, Chinese-Simplified, and Oromo at both meetings using designated phone lines.
