Should there be a material change in profile conformance, volume or facility acceptance protocols, pricing adjustments may be made. Any estimates provided under this agreement are "Time and Material" estimates. CUSTOMER will be invoiced based on unit rates multiplied by actual units.

Terms net 30 from date of invoice, upon approved credit. Labor charges are portal to portal with a two-hour minimum. Applicable sales tax will be added to materials. Minimum \$500.00 charge per invoice. Pricing is firm for 30 days from the date of this Exhibit A. An industry derived energy, insurance, and security assessment will be applied to all invoices, currently in the amount of 17% of the gross total, excluding sales tax. This assessment is an amalgamation of pass through costs and fees imposed by materials suppliers, transportation firms, and disposal facilities. This assessment may be adjusted from time to time, as industry conditions warrant.

Ingenium maintains all permits and insurances necessary for the completion of the work. Pricing is dependent on volume, facility acceptance and profile conformance. Should there be a material change in profile conformance, volume or facility acceptance protocols, pricing adjustments may be made.
