#### **Public comment invited**

The Washington Department of Ecology (Ecology) proposes removing the Environmental Covenant (covenant) from the Exxon Station 73594 site (Site). We invite your comment on this proposal.

Ecology will consider comments received during the comment period. If there are no significant changes, Ecology will remove the covenant from the Site.

#### **Environmental Covenant**

A covenant is filed on a property and recorded with the county when contamination is left at a site after cleanup. At this Site, concentrations of lead in groundwater were above state cleanup levels after the cleanup. The covenant protects human health and the environment by limiting the way the property is used.

#### **Background**

The Site is located at 13204 NE Hwy 99 in Vancouver (parcel number 186754000). A restaurant and parking lot are currently on the Site.

In the past, the Site was a service station with gas pumps, service bays, and six underground petroleum storage tanks. The underground tanks leaked petroleum, contaminating soil and groundwater. Before 1988, the tanks and pump island were removed from the Site.

From 1988 to 2002, studies showed petroleum contamination in soil and petroleum and lead contamination in groundwater.

The owner installed a system to remove petroleum vapors from soil and groundwater. The system removed about 1,290 pounds of hydrocarbon vapors from soil and groundwater. In 2008, tests showed that petroleum hydrocarbons in soil and groundwater had decreased below state cleanup levels.

In 2010, groundwater monitoring confirmed that lead concentration was above state cleanup levels. An environmental covenant was recorded for the Site in 2013. The covenant does not allow for any use of groundwater and for any activity that may interfere with the effectiveness of the cleanup.

In 2018, lead concentrations in groundwater had decreased and were below state cleanup levels. In 2020, Ecology issued a No Further Action Letter and the owner requested removal of the covenant from the property.
