Announcing the Availability of the Public Comment Responsiveness Summary

The Department of Ecology (Ecology) provided a public comment period for the Everett Landfill/Tire Fire Site (February 15-March 19, 1990), so that members of the Everett community could review and comment on documents relevant to the site. A Responsiveness Summary, containing Ecology's responses to written comments received during the comment period, is now available for review at either of the repositories listed in the box to the right.

Ecology received four letters of response during the public comment period.

Comments came from members of the Everett community, and the Snohomish Health District. Three of the letters contained specific comments that are addressed by the Responsiveness Summary.

One letter was received requesting a public meeting so that members of the Everett community could receive further information on the Landfill/Tire Fire site, and offer further comment. This letter contained sixteen signatures from members of the Everett community. The meeting will be held on April 17, 1990 (7:30-9:00 pm) at the following address:

What will the Public Meeting Address?

Ecology and the City of Everett are proposing an agreement to investigate the presence of hazardous substances at the Everett Landfill/Tire Fire Site, 2902 36th Street SE, Everett, Washington. The agreement, also called a Remedial Action Order on Consent, is a legal document that defines the scope of the investigation to be performed and the responsibilities of all the parties involved.

At the public meeting, Ecology and the City of Everett will provide information on plans for the remedial investigation, and address concerns expressed by members of the Everett community during the public comment period. There will also be an opportunity to ask questions, and make comments on the proposed work-plan that will guide the investigation.
