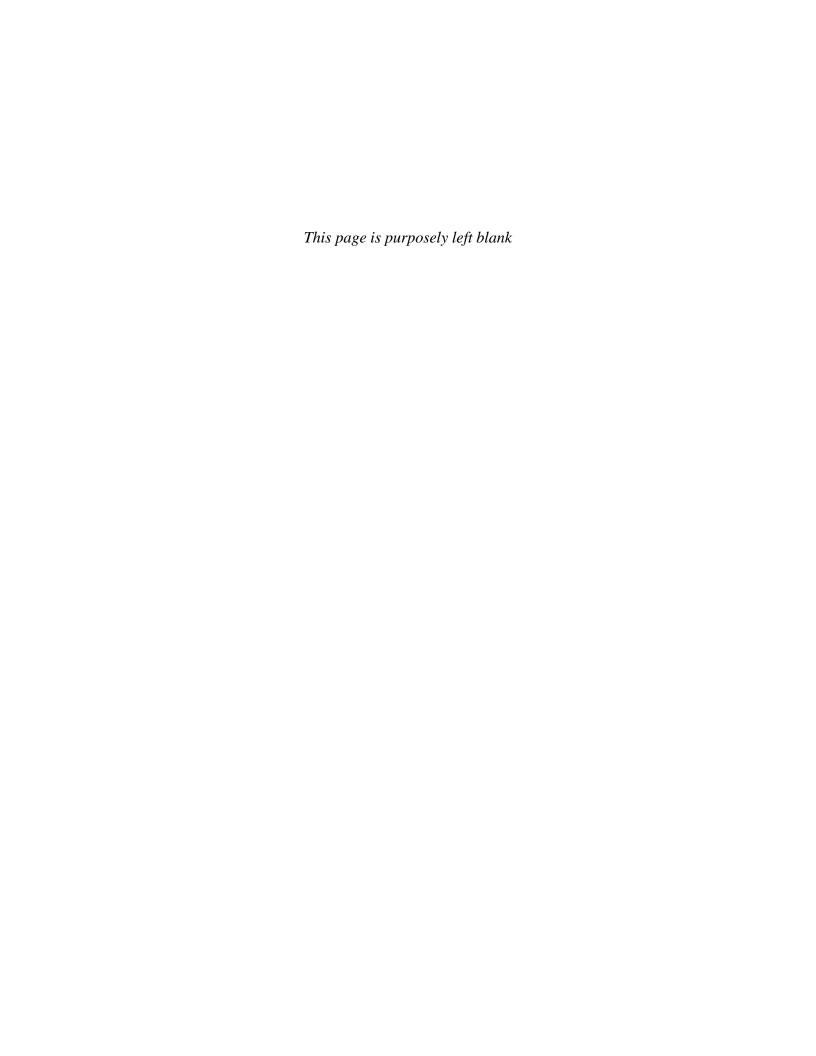

### **Public Outreach**

From March 18 to April 16, 2019, the Department of Ecology (Ecology) solicited public comments on an amendment to an agreed order (legal agreement) for the South State Street Manufactured Gas Plant cleanup site (Site) on the Bellingham waterfront. The amendment requires development of a cleanup action plan and design documents to address contamination at the Site.

Our public involvement activities related to this 30-day comment period included:

#### • Postcard:

- US mail distribution of a postcard providing information about the cleanup documents and the public comment period to approximately 2,100 people including neighboring businesses and other interested parties.
- Email distribution of the postcard to approximately 200 people, including interested individuals, local/county/state/federal agencies, and interested community groups.

o Publication of one paid legal ad in *The Bellingham Herald*, dated Friday, March 15, 2019

## **Next Steps**

Later in 2019 or early 2020, Ecology will make a draft Cleanup Action Plan available for public review and comment. This draft Cleanup Action Plan for the Site is based on the information in the final Remedial Investigation and Feasibility Study report.

## **Comments and Responses**

Ecology has reviewed and considered all comments received on the amendment to the agreed order. Based on Ecology's evaluation of the comments, no changes were made to the documents, and they are being finalized.

The comments are presented below, along with Ecology's responses. Appendix A, on page 5, contains the comments in their original format.

## **Comment from: Scott Moore**

Thanks for the opportunity to provide comments. I agree with the clean up effort, but have some comments. While I do agree with the clean-up proposal my preference would be to completely remove the toxins though I realize it may not be practical or fully needed. One dilemma I have is that currently (if I'm my interpretation and understanding of the clean-up effort is correct) is that presently the in-water toxins are not considered a hazard as time has rendered them less harmful or not dangerous to life, thus I'm wondering if or why removing or capping the in-water toxins is actually needed at this point especially as the mere passing of time has and is diluting the harmful chemicals!

Another area of concern is the toxin contamination surrounding the railroad tracks. I realize the difficulty and complexity to address this area as it's an active rail line, but it seems this hazardous area of concern is being ignored and would like to see if some kind of arrangement with the railroad could be found to mitigate this location of toxin issues!

I've been following the past proposals to construct a new northern in-water boardwalk route from Boulevard park to a projected new park along the waterfront area (the location of an old city dump I believe) and I was wondering how this toxic clean-up effort is going to impact that project?

I would like to commend all the entities for addressing these past hazardous occurrences and making our community a better and safer place to live and play. Thank you all for your good efforts as it's much appreciated and applicated.

#### Response:

Complete removal of the contamination was evaluated but determined unnecessary to eliminate the risk of exposure or to meet the required cleanup standards. This determination was supported by the results of a disproportionate cost analysis (DCA) that was conducted for the complete removal alternative.

Ecology does not consider the "in-water" (i.e., sediment) contamination non-hazardous and the contaminants are not being diluted. Under the MTCA, elimination of exposure pathways may be an acceptable remedy. In this case, the application of a sand cap or capping by enhanced and monitored natural recovery was determined an effective remedy to eliminate the risk of exposure.

We did not collect data from the railroad right-of-way (ROW). The current railroad tracks and ballast are constructed on top of the historic ground surface. Ecology will require that land use or administrative controls be implemented to address the potential for any future exposure to contamination that may be present beneath the railroad ROW.

The cleanup of this site will have no direct impact on the possible future development of an over-water walkway connecting Boulevard Park with the Cornwall landfill site.
