

### **Public Outreach Summary**

The Sea K Fish cleanup site (Site) located at the Blaine Harbor is beginning Washington State's formal cleanup process<sup>2</sup> as directed under the Model Toxics Control Act (MTCA<sup>3</sup>). The Port of Bellingham (Port) operates Blaine Harbor and manages the Sea K Fish property under an agreement with the Department of Natural Resources.

The Department of Ecology's public involvement activities related to this Site's 30-day comment period (October 12 – November 10, 2020) included:




Figure 1: Washington's formal cleanup process
