Enclosed is your Modified National Pollutant Discharge Elimination System (NPDES) Waste Discharge Permit No. WA0044784. This Modified NPDES Permit satisfies the requirements of both federal and state laws.

The modified permit is identical to the original permit, with the exception of Special Condition S6. Pretreatment, which requires the implementation of the City of Kennewick Industrial Pretreatment Delegation. Please have your staff replace the original page of the permit with this revised page for each copy of the permit made.

A Public Notice of this modification was published in the Tri City Herald on June 28, and July 5, 2019. *No comments were received.* 

#### **Appeal Process**

You have the right to appeal this permit within 30 days upon receipt of this document. Pursuant to chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within 30 days of the date of your receipt of this document.
